

**2026 PHILLIES TICKET GIVEAWAY
OFFICIAL RULES
NO PURCHASE NECESSARY TO ENTER TO WIN.**

1. **ENTRY PERIOD:** The 2026 Phillies Ticket Giveaway (“Promotion”) period begins April 1, 2026 at 12:00am Eastern Time (“ET”) and ends August 31, 2026, at 11:59pm ET (the “Entry Period”).
2. **ELIGIBILITY:** Open to legal residents of the 50 United States and the District of Columbia who are 18 years of age (or the age of majority in their jurisdiction of residence, whichever is older) as of the date of entry. Winners will be responsible for their own transportation to and from the location of the game and lodging if applicable. Void where prohibited by law. Employees, officers, and directors, and their immediate family members (spouse, parent, child, sibling, and their respective spouses, regardless of where they reside) and members of the same household (whether or not related), of Sponsor, the MLB Entities and its respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers, advertising and promotion agencies, and any other entity associated with the Promotion are not eligible to participate or win a prize. “MLB Entities” means the Office of the Commissioner of Baseball (“BOC”), its Bureaus, Committees, Subcommittees and Councils, MLB Advanced Media, L.P. 3. **HOW TO ENTER:** To enter the Promotion, entrants must complete entry form at www.citizensbankpark.com. Limit one entry per email address. You are not required to complete portions of the official entry form that may request your permission for Citizens to call, email, or text you (including via an automated dialer, or artificial or prerecorded voice message) regarding other bank products or services, where you do your banking, if you are a homeowner, and what banking products/services you are interested in. Such portions of the official entry form are optional, are not required to enter, and do not improve your chances of winning. If you do provide such permission, you understand that you are waiving your rights under any applicable “Do Not Call” list(s) that you may have registered with.
4. **WINNER DRAWING AND NOTIFICATION:** One (1) winner will be randomly selected on the following dates during the 2026 season – May 1, June 1, July 1, August 1, and September 1 for a total of five (5) winners. If any of those dates occurs on a weekend, winner will be selected on the following regular business day. Winners will be contacted via phone number and email provided on their entry form. Winner will have 72 hours to respond/claim the prize, after 72 hours, Citizens will have the discretion to select a new winner. Non-winning entries remain eligible for all future drawings. The odds of winning will depend on the number of eligible drawing entries received at the time of each drawing. Drawing will be conducted by Sponsor, whose decision is final on all matters relating to the Promotion. Return of prize, prize notification or unclaimed prizes as undeliverable may result in disqualification and alternate determination/selection.

5. **PRIZES:** Each winner will receive two (2) tickets total: one (1) for winner and one (1) for a guest to a mutually agreed upon 2026 regular season Phillies home game to be played at Citizens Bank Park (subject to availability and blackout dates) (Approximate Retail Value: \$150.00 each).

Use of any Major League Baseball game/event/exhibition ticket is subject to the standard terms, conditions, and health and safety policies applicable to the ticket; see phillies.com/ticketback for details. Seat locations at the game/event/exhibition and, unless otherwise stated in the applicable prize description, exact game/event/exhibition date shall be determined in the sole discretion of Sponsor. Each winner's guest(s) must be of legal age of majority in their jurisdiction(s) of residence unless accompanied by a parent or legal guardian. Major League Baseball game/event/exhibition dates and times are determined in the sole discretion of the BOC and/or the applicable Club and may be subject to change. Sponsor and the MLB Entities will not be responsible for weather conditions; acts of God; acts of terrorism; civil disturbances; local, state, or federal regulation, order, or policy; work stoppage; epidemic, pandemic, or any other issue concerning public health or safety; or any other event outside of their control that may cause the cancellation or postponement of any Major League Baseball game/event/exhibition. Major League Baseball game/event/exhibition tickets awarded as prizes may not be resold, offered for resale, or used for any commercial or promotional purpose whatsoever. Any such resale or commercial or promotional use may result in disqualification and prize forfeiture, and may invalidate the license granted by the game/event/exhibition ticket.

Sponsor reserves the right, in its sole discretion, to disqualify any individual they find to be acting in violation of these Official Rules, any individual that tampers or attempts to tamper with the entry process or the operation of the random selection process, acts in an unsportsmanlike or disruptive manner, or acts with intent to annoy, abuse, threaten, or harass another person. Any attempt by any person to deliberately undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. The failure of Sponsor to enforce any term of these Official Rules shall not constitute a waiver of that provision. Entries generated by script or bot are not eligible.
