

CITIZENS BIB GIVEAWAY: 2026 TCS NEW YORK CITY MARATHON
OFFICIAL RULES
NO PURCHASE NECESSARY TO ENTER TO WIN.

1. **ENTRY PERIOD:** The Citizens Bib Giveaway: 2026 TCS New York City Marathon (“Promotion”) period begins 9:00am ET on June 15, 2026, and ends at 5:00pm. ET on June 30, 2026 (the “Entry Period”).
2. **ELIGIBILITY:** Open to legal residents of the New York City metropolitan area, defined as residents of New York City (the five boroughs of Manhattan, Brooklyn, Queens, The Bronx, and Staten Island) and the counties of Nassau, Suffolk, Westchester, Rockland, and Putnam, who are at least eighteen (18) years of age (or the age of majority in their jurisdiction of residence, whichever is older), who are existing Citizens customers as of the date of entry, who are not employed by Sponsor, or Sponsor's affiliates as of the date of entry (“Entrants”). Entrants must meet these eligibility criteria at the time of entry and prize drawing to be eligible to win.
 - a. Bibs are not eligible to anyone who is already registered to run this year’s race,
 - b. You must be in good standing with New York Road Runners (NYRR),
 - c. All entrants must comply with [NYRR Guidelines and Procedures](#).
3. **HOW TO ENTER:** Visit the entry page. On the entry webpage, the entry form may request, among other things, his/her/their full name, complete mailing address that includes the City, State and Zip Code (no P.O. Boxes), telephone number, email address, and related registration information as prompted. Entrant must complete and submit the official entry form with all required information for the entry to be eligible. One entry per person. You are not required to complete portions of the entry form that may request your permission for Citizens to call, email, or text you (including via an automated dialer, or artificial or prerecorded voice message) regarding other bank products or services, where you do your banking, if you are a homeowner, and what banking products/services you are interested in. Such portions of the entry form are optional, are not required to enter, and do not improve your chances of winning. If you do provide such permission, you understand that you are waiving your rights under any applicable “Do Not Call” list(s) that you may have registered with.
4. **WINNER DRAWING AND NOTIFICATION:** Five (5) people will have the opportunity to win one (1) 2026 TCS New York City Marathon bib to run the 2026 TCS New York City Marathon on November 1, 2026. Winners will randomly be drawn in July 2026. A colleague at Citizens, teamcitizens@citizensbank.com, will reach out to each of the winners to announce they’ve won by July 10, 2026. Winners will be contacted via the email and/or phone number that they provided on the entry form. Winners must respond to the email from Team Citizens, accepting the bib within a week of the email from Team Citizens, to remain eligible for the bib. Team Citizens will provide the next steps for how to secure the bib. If winners do not respond to the email sent from Citizens within one week, they will be disqualified. Odds of winning will depend on the number of eligible entries received during the Entry Period. If selected as a winner, the winner is solely responsible for any and all costs and expenses associated with the prize, including but not limited to travel, transportation, airfare, lodging, hotel accommodations, gas, meals, and any other incidental expenses incurred in connection with participation in the TCS New York City Marathon on November 1, 2026. Potential winners may be required to verify their eligibility by completing, signing, notarizing, and returning an Affidavit of Eligibility/Liability Release, and, where lawful, a Publicity Release (granting Citizens the right to use his/her name, picture/portrait likeness and/or voice, or Submission for advertising/publicity purposes without further compensation) or the prize may be forfeited and an alternate potential winner may be selected.

5. **PRIZES:** Prize per winner is one (1) bib to run the 2026 TCS New York City Marathon on November 1, 2026. The ARV is \$315.00 (three hundred fifteen dollars). Winners will also receive a Team Citizens swag bag valued at \$100.00 (one hundred dollars) ARV.
6. **TAXES:** By receipt of a prize, each winner agrees that he/she is responsible for all federal, state, and local income tax liability on such prize and all other obligations and expenses that are associated with receipt and use of the prize regardless of the value.
7. **PUBLICITY:** By entering the Promotion, Entrant grants Sponsor and its affiliated companies the right to use Entrant's name, likeness and/or photo for promotional purposes (including any possible public relationship opportunities) without further compensation except where prohibited by law.

Sponsor reserves the right, in its sole discretion, to disqualify any individual they find to be acting in violation of these Official Rules, in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. The failure of Sponsor to enforce any term of these Official Rules shall not constitute a waiver of that provision.

10. **DISPUTES:** Entrants agree that: (a) any and all disputes, claims, and causes of action arising out of or connected with this Promotion, or any prize awarded shall be resolved individually, without resort to any form of class action, and solely and exclusively in a federal or state court located in the State of Rhode Island; Entrants submit to sole and exclusive personal jurisdiction to said courts in the State of Rhode Island for any such dispute and irrevocably waives any and all rights to object to such jurisdiction; (b) any and all claims, judgments, and awards shall be limited to actual out of pocket costs incurred, including costs associated with entering this Promotion but in no event attorneys' fees; and (c) under no circumstances will Entrants be permitted to obtain awards for and Entrants hereby waive all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
